The financial report was presented by Pres. Scott with the General Account having \$25,466.26 and the Horse Show Account having \$9,942.91 with a combined total of \$35,409.17 as of 2/17/13. P. Bramerloh will take over the treasurer responsibilities with T. Ware as the second signee. The Bank of Kentucky will be the bank the funds are to transfer. Move that monies be transferred and the second signee be approved, second, motion carried.

The minutes from the afternoon meeting January 12, 2013 were reviewed and one correction reported. Darrell Collins should be added to the Midsummer Classic Horse Show Program Committee. Duly noted, minutes corrected. Move the minutes be approved after correction, second, motion carried.

Pres. Scott presented Laurie Herchenroeder as his nomination for KWHA Secretary. Move that Pres. Scott's nomination be accepted, second, motion carried.

- L. Herchenroeder presented a bid of \$850 for typesetting the 2013 KWHA Blue Book. Move to accept the bid, second, motion carried.
- L. Herchenroeder presented committee findings for pricing of the Blue Book for previous years.

Pres. Scott presented Joe Fraley as his nomination for Horse Show Manager for the Midsummer Classic Horse Show. Move that Pres. Scott's nomination be accepted, second, motion carried.

Pres. Scott suggested a double point system and partnership between KWHA and three other associations; CKRHS, OVWHA, EKWHA. These three shows will count as double point shows for KWHA members. The Midsummer Classic Horse Show would count as double points for these associations as well. Move that we accept this proposal, second, motion carried.

Discussion to make Midsummer Classic Horse Show a triple point for KWHA members. Move that we accept this proposal, second, motion carried.

Presented proposed changes to the Midsummer Classic show bill. These changes included; splitting Country Pleasure Class into men & women's, moving Trail Pleasure Racking Class to later in the show, eliminate 2 yr old Amateur Class, combine Open 2Yr Old mare/gelding and stallion/gelding classes to Open 2 Yr Old Class, do the same for Open 3 Yr Old classes, drop 4 and Under Park Performance Class, add an open Pleasure Horse Championship Class. Move to accept the presented show bill as proposed, second, motion carried.

Move a secondary amendment to allow the Open 3Yr Old Class to be divided as Open 3yr Old mare/gelding and stallion/gelding classes, and add a Speed Racking/Pacing Class, second, motion carried.

Horse Show committee discussion resumed. The date for the Horse show is August 10, 2013 at 4:00pm. Entry fees, ribbons and payouts to remain the same. The KWHALA Queen Contest will be crowned prior to the show at 3:30 pm. Robin Tolle will be the organist, Dan Grigson the announcer and Natasha Douglas the photographer.

Move that we affiliate with the following associations; OVWHA, CKRHA, CKHSA and EKWRHA., second, motion carried.

Move that we send notification to members of the judge's list of their availability to judge the Midsummer Classic Horse Show by May 20<sup>th</sup> and have it returned by May 31<sup>st</sup>, 2013. Then, this list will be sent to the KWHA members by June 8<sup>th</sup> and have it returned by June 22<sup>nd</sup>, 2013 to determine a judge for the show. Second, motion carried.

Move that no changes can be made to the show bill after publishing, second, motion carried.
